CORRIGENDUM



Reference Tender No. Col/Com/228/4/2010-Equip dated 7 June 2015 for Supply of Medical Equipment to Dickoya Hospital, Hatton, Sri Lanka.

Bidders may note the following changes in the Tender documents:

1. Terms & Conditions

Clause 2: Last date for issuance of tender document is extended till 30 June 2015. In the event of Demand Draft, bidders are required to take before 30 June 2015

Clause 3: The technical bids will be opened in presence of authorized representatives of bidders <u>at 1530 hrs on 10 July 2015</u> in the High Commission of India, Colombo, Sri Lanka

Clause 6: Bid may be submitted on or before 1500 hrs on 10 July 2015

Clause 7: Bidders are required to bid for entire items in a package. Those who are not an authorized agent of particular equipment in a package, can trade that equipment from an authorized agent to bid for the tender. In that event, the bidder has to produce the manufacturer's authorization letter along with the letter from the authorized agent.

Clause 8: The technical bids will be opened in presence of authorized representatives of bidders at 1530 hrs on 10 July 2015 in the High Commission of India

Clause 13: Packages for Bidding: Bidders may read Earnest Money Deposit (Bid Bond) for package eight as mentioned below

Clause 16: With Financial Bid (ii) may be corrected as 'The Price should be quoted in Sri Lankan Rupees for local Bidders and in Indian Rupees for Indian Bidders. The applicable rate of exchange is INR 1 = SLR 2.0743

Bidders may also note the following:

- I. For the purposes of import of the medical equipment, the consignee shall be Ministry of Health, 385, Ven. Baddegama Wimalawansa Thero Mawatha, Colombo 10. The consignee will facilitate exemption from payment of custom duties, VAT and other taxes.
- II. Bidders who bid for the X-Ray machine are advised to visit the hospital prior to quoting the tender
- III. Bidders should quote price inclusive of installation and commissioning of equipment

2. Annexure A – Technical Specification Form:

- I. Package One: Phototherapy Unit- Power of bulb is 100 watts
- II. Package Four: Item No 1 (Ultrasound with facility & Color Doppler +3 Probs) should be removed from package four
- III. Package Eight: Bidders should add "Ultrasound with facility & Color Doppler +3 Probs" as a new item under package eight. Specification for this new item shall remain as mentioned in Package four, item no.1.
- IV. Package Ten: Centrifuges: is for the clinical purpose Clause 3, Sub-clause 3.3: volume of the tube is 7ml
- V. Bidders have to submit manufacturer's calibration certificate for the equipment which require calibration certificate and 3rd party inspection report to be obtained pre-shipment.
- VI. Bidders required to replace word "Indian plugs" with "standard plugs" where ever mentioned in the Annexure A
- VII. Bidders required to replace word "Indian Standard" with "International Standard" where ever mentioned in the Annexure A
