Clause 12 - With the Financial Bid (point ii): Companies shall submit their quote in Sri Lankan Rupees (SLR) or United States dollar (USD).

Clause 16 -PERFORMANCE GUARANTEE: The successful bidder shall submit, within **fourteen** working days after the award of tender, a Performance Guarantee provided by a commercial bank approved by the Central Bank of Sri Lanka, of an amount equal to five percent (5%) of the value of order, drawn in favor of the “High Commission of India, Colombo” for the due execution of the contract within the specified period. **Indian bidder may submit the performance guarantee in US Dollar at the official rate of exchange drawn in favor of the “High Commission of India, Colombo”, from "State Bank of India" payable at “State Bank of India, Colombo”,** for the due execution of the contract within the specified period. The Performance Guarantee should be valid for a period of **60 days beyond the warranty period** from the date of award. If the Performance Guarantee is not submitted within **14 days** of the letter of award, the award will be cancelled and the Guarantee will be forfeited. The EMD of the bidder, whose tender is accepted, will be discharged when the said bidder’s Performance Guarantee has been accepted.
